"Traditional, hardware-centric PACS systems have a native inability to meet U.S. Federal systems requirements without the addition of relatively expensive third-party solutions," continued Mr. Raefield. "Viscount's Freedom platform allows our customers to manage access control using low cost, IP encryption bridges that are highly-secure, compliant and scalable.
